Full-time Position



The Aleza Lake Research Forest Society seeks a registered forest professional or allied natural resource professional for a full-time staff position at a university research forest near Prince George, British Columbia. This position is scheduled to commence in Spring 2022.

The Aleza Lake Research Forest Society (the "ALRF") is a non-profit society, and a partnership of the University of Northern British Columbia (UNBC) and the Province of BC. The ALRF is a 9,000-hectare research-forest tenure located 60 km east of Prince George BC. ALRF offices are located at the UNBC campus. The ALRF's mandate is to facilitate forest-based education and scientific research. The ALRF land base is managed for a range of ecological, social, and economic values under the ALRF Management Plan, including working forest as well as protected ecosystems and old-growth forests. The Research Forest includes the Aleza Field Education Centre, a log-and-timber classroom facility for field-based teaching activities and events.

The ALRF Projects Supervisor provides professional and logistical staff support under the direction and oversight of the ALRF Manager, Assistant Manager, and the Society, in diverse areas of resource and ecosystem management and practice. These include but are not limited to:

1. ALRF land management and tenure responsibilities including timber and non-timber values, silvicultural operations, forest roads, forest inventory and assessments, and related activities.
2. Land information management including non-timber resource values.
3. Field-oriented teaching, research, and extension activities.
4. Contributing to planning processes for forest harvesting and access management.
5. Budget management and financial reporting to ALRF Society standards.
6. Aleza Field Education Centre activities, logistics, and management. And;
7. Supervision of contractors, and supervision and development of junior staff members.

The ALRF seeks a candidate for this position with all of the following qualifications:

- a) Well-rounded operational experience (minimum 2-3 years) in field-based forestry, forest ecosystems, and natural resource operations, including contractor and/or staff supervision.
- b) Demonstrated organizational and project management skills.
- c) Registered (or immediately eligible for registration) with one or more of the following natural resource professions: (a) the Association of BC Forest Professionals (ABCFP, with RPF or FIT designation); and/or (b) College of Applied Biologists of BC; and/or (c) the BC Institute of Agrologists.
- d) Operational forestry and natural resource experience in BC Interior and/or western boreal forest ecosystems.
- e) Good verbal and written communication skills, and ability to work collaboratively with diverse groups.
- f) Sound working knowledge of related British Columbia legislation and regulations. And;
- g) Physical fitness and demonstrated capability to efficiently meet job requirements in a wide range of weather and field conditions.

Compensation will be commensurate with experience, responsibilities and professional qualifications relative to requirements of this position, with a starting salary between \$ 55,500.⁰⁰ to \$ 62,500.⁰⁰ plus benefits. The ALRF Society provides a competitive employee benefits package.
